## A RESOLUTION TO PURCHASE THREE VEHICLES WITH WISCONSIN DEPARTMENT OF TRANSPORTATION 85.21 GRANT FUNDS

WHEREAS, Buffalo County Department of Health and Human Services (DHHS) operates two vehicles for purposes of providing for the transportation needs of senior and disabled Buffalo County residents, and;

WHEREAS, these two vehicles, a 2001 Ford E350 full sized van and a 2001 Chrysler Town and Country minivan have high mileage and significant maintenance needs, and;

WHEREAS, these are stationed at the Alma and Nelson Senior Dining meal sites, and;

WHEREAS, demand for senior and disabled transportation has increased to the point where staff fleet vehicles are being used causing increased staff mileage reimbursement expense due to fleet vehicle lack of availability, and;

WHEREAS, Buffalo County's 85.21 Department of Transportation Grant reserve fund is projected to have a balance of over \$185,000 at the end of 2018 and the Wisconsin Department of Transportation recommends spending down this fund below \$80,000 by the end of 2018, and;

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors hereby authorizes DHHS to purchase two minivans to replace the 2001 Ford E350 and the 2001 Chrysler Town and Country using 85.21 funds, and;

NOW, THEREFORE LET IT BE IT FURTHER RESOLVED, that the Buffalo County Board of Supervisors hereby authorizes DHHS to purchase a handicap accessible minivan.


